Background

The Renewables Portfolio Standard (RPS) requires retail sellers of electricity and local publicly owned electric utilities (POUs) to increase the amount of renewable energy they procure until 50 percent of their retail sales are served by renewable energy by December 31, 2030. The Energy Commission is required to certify eligible renewable energy resources that retail sellers of electricity and POUs may use to satisfy their RPS procurement requirements, develop an accounting system to verify retail sellers' and POUs' compliance with the RPS, and adopt regulations specifying procedures for

enforcement of the RPS for the POUs. The Energy Commission adopted the regulations June 2013, and they became effective October 1, 2013.

In October 2013, the passage of Senate Bill (SB) 591 (Canella, Chapter 520, Statutes of 2013) amended Section 399.30 of the Public Utilities Code related to the RPS for POUs. SB 591 provided that a POU is not required to procure additional eligible renewable energy resources in excess of specified levels if it receives 50 percent or greater of its annual retail sales from its own hydroelectric generation meeting specified requirements. The Energy Commission amended regulations for POUs to implement SB 591, and to make other clarifications to existing provisions. The amended regulations were adopted by the Energy Commission on October 15, 2015, and they became effective on April 12, 2016.

On October 7, 2015, SB 350 (de León, Chapter 547, Statutes of 2015), also called the Clean Energy and Pollution Reduction Act, was signed into law establishing new clean energy goals for 2030 and beyond. Among other things, SB 350 increases California's RPS procurement goal from 33 percent by 2020 to 50 percent by 2030. To implement new provisions in SB 350 relating to the RPS, the Energy Commission adopted an Order Instituting Rulemaking proceeding at its January 13, 2016, business meeting.

SB 350 makes the following changes to California's RPS program, to be incorporated in the *RPS Regulations*:

- Establishes new RPS procurement targets for POUs: 40 percent renewables by December 31, 2024, 45 percent by December 31, 2027, and 50 percent by December 31, 2030
- Requires POUs to procure more renewable resources through long-term contracts; beginning January 1, 2021, at least 65 percent of procurement must be from contracts of 10 years or more in duration or from ownership agreements
- Revises rules for the calculation of excess procurement used to satisfy POU's procurement requirements for subsequent compliance periods
- Establishes requirements for offsetting retail sales served by a POU's voluntary green pricing program or shared renewable generation program
- Creates special exemptions for POUs procuring electricity from qualifying large hydroelectric generation and for POUs that have qualifying unavoidable long-term contracts for electricity from coal-fired power plants

In addition to implementing relevant sections of SB 350, staff is proposing minor revisions to the regulations to streamline reporting requirements, and to clarify other existing provisions.

Development of the amendments to the *RPS Regulations* is currently in the "prerulemaking" phase. As needed, pre-rulemaking workshops are held by the Energy Commission to seek early public input for developing and refining draft regulations. The "rulemaking phase" (45-day language) commences with the publication of a Notice of Proposed Regulatory Action and proposed regulations. Once adopted by the Energy Commission, the regulations will be submitted to the Office of Administrative Law for review.
